Separate sealed bids from Qualified Contractors for the construction of The WTP No. 2 Aerator Replacement Project, Project No. 100168.21, Bid No. 2015-31, will be received by the City of Perry Purchasing Department, Georgia, Attention: Brenda King, 1211 Washington St., Perry, GA, 31069, until 2:00 P.M. legal local time on Tuesday, July 14, 2015 and then publicly opened and read aloud. Bids submitted by mail or courier must be received before the time stated above and marked as stated herein. Any bids received after the time and date specified will not be considered and will be returned unopened. All bidders must meet the requirements set forth in Section 00100 – Instructions to Bidders to be qualified to bid this work.

A mandatory pre-bid conference is scheduled for 10 A.M. local time on Tuesday, June 30, 2015. The conference will be held at the Water Treatment Plant No. 2 (110 Woodlawn Drive). You must attend and sign-in at this pre-bid conference to be allowed to submit a bid. Contractors may be allowed to inspect the project area after the conference.

The project generally consists of removal of one of the existing 2.0 mgd aerator for iron and carbon dioxide removal and replacement with a new aerator providing similar performance.

The Work shall be substantially complete in all respects 150 days from the notice to proceed.

The Bids permitted above shall be made only by filling in the blanks provided in the proposal. Any bid qualified by writing in any other way than specifically stated above will not be considered.

The CONTRACTOR shall perform a minimum of 50 percent of work by his own work forces unless specifically authorized by the OWNER and ENGINEER and no Subcontractor shall be allowed to perform work on the project unless they are acceptable to the OWNER and ENGINEER.
